AGE FRIENDLY SACO COMMUNITY LUNCHEON PROGRAM

In 2023, Age Friendly Saco (AFS) was awarded a federal grant to begin a multi-community meals program. The requirements of the grant included offering healthy balanced meals with an opportunity for socializing. Five volunteers, Glenn, Jon, Lucie, Susan and Teri, were responsible in developing today's popular community luncheons. These five volunteers are known as the Kitchen Five or **"K5"**, a nickname created by one of our members!

Each monthly meal requires many volunteer hours of meal preparation time to meet and decide the details of the menu for 85 -100 guests, test the recipes for the "made from scratch" meals, shop for food at multiple places and store the supplies. AFS is grateful to the Elks Lodge in Saco for donating the space for two storage cabinets to hold non-food items. However, K5 must still transport purchased food items to the Elks Club the morning of the luncheon. Luncheon day, K5 arrives at the Elks Club at 8:00 am but by 8 AM, **K5** has been preparing/cooking portions of the meal the day prior or very early that morning. Each **K5** member knows their task----kind of like organized busy bees!

"It's gratifying to us to volunteer as this "K5" group, which has created such an appreciated program."

"K5" has served 1126 meals, and given nearly 1800 volunteer hours. Outside of the luncheon program, **"K5"** has served meals to the Veteran residents at the Kimball Center in Saco. Through grant funding **"K5"** was also able to offer crock-pot cooking classes to 35 seniors.

Congratulations Age Friendly Mobility Shuttle....

The Age Friendly Saco Mobility Shuttle recently celebrated its first year in operation on October 23rd. Through November 2024, the Saco Mobility Shuttle has provided 843 rides. A synopsis of the places we have provided rides to are: Walmart, Hannaford, Shaws, Market Basket,

Community Pharmacy, Post Office, local banks, City Hall, Saco Food Pantry, Cohen Center and Election Polls to name a few.

Outside of our regular schedule, the Shuttle has also recently commenced providing rides to the Saco Food Pantry one day per week for our immigrant community who are currently being housed in Saco.

The Saco Mobility Shuttle provides door-to-door transportation to Saco Residents aged 60 years of age or older for groceries and daily living needs. The Shuttle provides regularly scheduled stops and can also provide transportation to other business locations by request.

Currently, the Shuttle runs Monday, Wednesday and Friday from 8 AM to 1 PM. Shuttle riders must be independently mobile and must be able to embark and disembark without assistance into a passenger van with steps. For more infor-

Community Connector



Hi, my name is Joe Moreshead, the new Community Connector at Age Friendly Saco. Did you know surprisingly, that slips and falls remain a significant issue in Saco. According to Chief Dave Hamel of the Saco Fire Department and Head of EMS, the department responded to over 5,000 ambulance calls last year, with most of them related to falls.

To address this, Age Friendly Saco (AFS) has set an ambitious goal: reducing these incidents and helping residents stay safe in their homes. Together with Chief Hamel and Rebecca Lyons, Outreach Coordinator at the Saco Police Department, I'm here to help community members who could benefit from a few modifications to make their homes safer.

Our approach includes inviting residents to schedule a free Home Assessment. During these visits, we evaluate potential hazards like slippery rugs or dim lighting and may suggest adding grab bars or nightlights. Did you know some toilet paper holders now double as grab bars? We use a checklist developed

by AARP, guiding us through each room to spot and discuss any risks.

In addition to our recommendations, AFS has a team of "handy helpers" available to make suggested adjustments, like installing grab bars or adding hallway lights, and we can provide these items when needed.

Even if you haven't had a fall, proactive safety is crucial. If you or someone you know could use a home assessment, please contact Age Friendly Saco or email me at connector.agefriendlysaco@gmail.com. Let's find ways to work together to help you feel safer and prevent those dangerous slips and falls.

PROPERTY TAX FAIRNESS CREDIT

Are you aware that you could be saving thousands of dollars by taking advantage of these property tax savings programs? According to the latest census data for the City of Saco it would appear that far more residents qualify for not only the Property Tax Fairness Credit (a State program), and in turn also the municipal match from the City of Saco. Last year only 138 residents of Saco received the tax credits but it would appear, looking at the census data, that many more households would qualify to take advantage of these tax savings programs under the current income requirements. Since being able to apply for our municipal program depends on applying for the 1040ME form. Their program is very popular, PTFC (Property Tax Fairness Credit), the income eligibility for this program

How to apply:

(1) PROPERTY TAX FAIRNESS CREDIT (PTFC)

Eligible Maine taxpayers may receive a portion of the property tax or rent paid during the tax year on the Maine individual tax return whether you owed Maine income tax or not.

Who is eligible:

Homeowners of renters who meet all of the following requirements:

- Were Maine residents for any part of the tax year;
- Owned or rented a a home in Maine during any part of the tax year and lived in that home during the tax year as the primary residence;
- Paid property tax or rent on the primary residence during the tax year;
- Meet certain income and property tax and/or rent paid limitations during the tax year; https://www.maine.gov/revenue/taxes/tax-relief-creditsprograms/income-tax-credits/property-tax-fairness-credit and
- Are not married filing separately.

How does one apply for this refundable credit?

To claim the credit, file form 1040ME and Schedule PTFC/STFC for the tax year during which the property tax or rent was paid.

This is a state program designed to balance your income and the amount of property tax that you paid. If the amount of the property tax (and in some cases rent) paid exceeds a certain percentage of your income, you could receive a refund from the State. Also, if you have not applied for the PTFC before, it is possible to go back three years to claim refunds that would have been due you for those years. To receive the PTFC, you need to file a 1040ME income tax form every year, even if you do not owe any money or if you are no longer required to file Federal taxes. The IRS is not involved in any way, and your Social Security is not effected. Help is available to file the 1040ME.

(2) SACO SENIOR TAX ASSISTANCE PROGRAM

If you are 65+ and have lived in Saco for at least ten consecutive years as of April 1st, and have filed the 1040ME form and the PTFC by April 1st, the City will match the amount of the PTFC refund you received and apply that amount to the first half of the next property tax bill. As with the PTFC, you must apply every year. You also need to have the Homestead Exemption (https://

www.maine.gov/revenue/fag/homestead-exemption-program#g3) and your property tax payments must be up to date. Many more Saco residents were qualified for the Tax Assistance Program last year, but did not take advantage of the program. Age Friendly Saco hopes to offer workshops next year to provide help with filing and applications. TAX FILING REMINDER

Our next newsletter will be in March, so we want to remind you now to be sure to get your 1040ME form filed BEFORE 4/1/25 if you plan to take advantage of the Property Tax Fairness Credit and/or the Saco Senior Tax Assistance Program. There are programs available to help file the forms.
