This medical transportation service is free. Our volunteer drivers utilize their own vehicles to transport you to your medical appointment and return you to your residence.


Some riders request to pay something for the transportation. While payment is not necessary, anyone seeking to make a donation may do so to Age Friendly Saco.

About our Transportation Team

Age Friendly Saco's Medical
Transportation Team commenced with
two AmeriCorps Members in February
2022. Since that time, the program has
blossomed to 14 volunteers. Over
1,265 rides from Kennebunk to
Falmouth have been provided, 11,514
miles were traveled, and 1,306 hours
have been spent getting Saco resident
to their medical appointments. We
currently have enrolled approximately
70 riders and the program continues to
expand to service more individuals.

Ride Information

To schedule a ride, call our Medical Appointment Transportation Program Director at (207) 200-7668. You may need to leave a voicemail message. The Program Director will return your call.

Transportation Drivers will transport you to your appointment, wait for you and return you to your residence.

Age Friendly Saco has performed background checks on all Drivers and obtained vehicle insurance information from them.

Transportation Drivers are screened, trained and required to adhere to confidentiality of information from our Riders.

Since we are dependent on volunteer availability, a <u>7-day notice is required</u> to schedule a ride.

The distance to appointments is no further North than Falmouth and no further South than Kennebunk.

All passengers MUST wear seatbelts. NO smoking in the vehicle. NO alcohol consumption, intoxication or open containers are allowed. Your driveway/roadway must be safely accessible for our volunteer's vehicle.

Schedule: Monday through Friday 8 AM to 5 PM

Driver Assistance

Medical Transportation Riders must be independently mobile and must be able to embark and disembark without assistance into a passenger vehicle. Our Drivers can only offer an arm or hand for assistance.

Drivers will open/close the vehicle door and help secure seat belts, if needed.

Drivers cannot enter a residence.

Drivers cannot act as a medical or physical attendant.

Drivers will store a walker once the Medical Transportation Rider is onboard.
